As many state legislative sessions are now underway, CCIA is providing a list of applicable crossover dates – deadlines that legislation must pass the originating chamber in order to be considered for the remainder of session – in addition to anticipated adjournment dates. Please note that some dates are approximations due to the counting of "legislative days" and may be subject to change depending on the state.
